1. Please mention the school code (provided by ACER India if the school has taken IBT earlier) in the space provided in the top left corner. Schools registering for the first time may leave the school code blank.
2. Please fill the school name legibly in the blocks provided, writing one letter per block. Leave a blank box between each word.
3. The school name as mentioned in this form will appear on all certificates and reports followed by the city name in brackets.
4. IBT question papers will be shipped only after full payment has been received by ACER India. Please make payments before the date mentioned in the offers section of this form. Delayed payments may result in late delivery of test materials and ACER India will not be responsible for such delays.
5. If the student count given in the form is not final, please share the final break-up of students before 15 September 2020. Without a confirmed count of students (class/subject wise), it will not be possible for us to despatch the question papers.
6. Minimum 1500 tests are required to be eligible for the IBT Plus.
7. Five percent (5%) extra papers will be sent to schools to accommodate any last minute addition of students. If the final count of answer books is different from the confirmed count, the higher of the two will be considered for calculation of payment.
8. GST has already been factored into pricing. However, any subsequent changes in government regulations or tax laws would be applicable as soon as they are implemented.
9. If a school is a part of a group and has opted for combined payment for group schools, payments done by any one school will be considered as a common payment for the entire group unless otherwise specified.
10. To be eligible for the offers, 30% advance will need to be paid within seven days of registration and the balance 70% by 1 September 2020.
